

- A term that is gaining prominence
- Social value refers to the benefits that an organisation can deliver to society through its activities and supply chain

What is social value?




Social value is

- a core consideration in ESG and investment decision making at global, national and local levels
- companies increasingly considering their own ESG position/social value contributions
- increasingly used by Local Authorities in considering approval for major projects

The real estate perspective

- The <u>Public Services (Social Value) Act</u> came into force 31 Jan 2013.
- The Act requires public authorities to consider in relation to public service contracts, "how what is proposed to be procured might improve the economic, social and environmental well-being of the relevant area"



The policy context 1/2

- In 2020, <u>The Social Value Model</u> was published, setting out five social value 'themes':
 - COVID-19 Recovery
 - Tackling economic inequality
 - Fighting climate change
 - Equal opportunity
 - Wellbeing
- From 1 Jan 2021, taking account of social value became a requirement in major government contracts including for construction and infrastructure projects (PPN 06/20).
- Also sits in the <u>National Planning Policy Framework (NPPF)</u> which includes a "social objective" for the planning system alongside economic and environmental objectives.

Current context













- Opportunity to define what it means for your local area
- Opportunity to focus on outcomes that matter i.e. access to green space, new jobs
- Ensuring alignment with local plans

Benefits

Measuring social value...

- <u>Social Value Model</u> specifies national policy priorities and provides guidance on use of the model, evaluation in tenders, and contract management etc.
- HACT UK Social Value Bank with a focus on housing
- <u>Themes, Measures and Outcomes Framework</u> gives proxy values to activities

[Caveat: Avoidance of considering social value as a tick-box exercise]



Case study - <u>Salford</u>



- Focus on getting social ROI and securing better outcomes i.e. to secure social value from Regeneration, Housing and Planning activity*
- Social value gained through
 - developer partners, construction projects, Housing trusts, S106 agreements, etc and
 - promotion with businesses, construction partners, etc
- Development of a toolkit for measuring and evaluating social value
